Rides available from 12.00 Midday till 11.00 pm.

This year Luna Park have allocated the Function area from 3.00 pm to 6.00 pm. The committee will be available from midday to hand out wrist bands for the rides and vouchers for presents, showbags, etc. if you wish to arrive early and take advantage of the all-day rides.

Prices:

- Members Children under 13 year: \$35 per child (Includes rides, present, show bag, meal)
- Note: Grandparents can have up to two grandchildren at the \$35 rate. \$55 per additional child.
- Adult (13+ years) with no rides: Free admission
- Adult ride tickets: \$39.95 per person.

Closing Date: Get your application in by the 22nd November 2019 to your local representative. Important: Payment must be completed & a form submitted prior by the closing date.

Safety: All children must wear solid footwear. Alcohol is not permitted.

Payment Options:

- **Cash Payment:** Fill in the form & hand it with your payment to your local representative.
- **Cheque Payment:** Make the cheque out to "Qantas Melbourne Welfare Council Inc." & either mail the application & payment or submit via your local representative.
- **Direct Deposit:** Make your payment into the
